"Meeting of UFBU was held today at New Delhi. Com.K.K. Nair, Chairman of UFBU presided over the meeting. The meeting whole heartedly congratulated and complimented all the Unions and the entire membership for making the strike action on 22<sup>nd</sup> August, 2017 a total success. The meeting observed that the despite the vehement and logical protest of the entire Bankmen of the country, the Central Government is trying to go ahead with their agenda of banking reforms. Although in retaliation to our strike, the Cabinet has decided and approved an alternative mechanism to oversee proposals of amalgamation of public sector banks. The Government has also issued the notification on 30.08.2017 on merger of nationalized Banks to be exempted from the purview of Competition Commission Act. Hence the meeting felt that when the Government is trying to move with such proposals, we should also plan and intensify our campaign and struggles there against.
