NATIONAL EXECUTIVE COMMITTEE MEETING **7TH OCTOBER 2018 : NEW DELHI**

"A Meeting of the National Executive Committee, under the Presidentship Com.S.C.Balaji, President of our organisation, was held on the 7th October 2018 at New Delhi.

Com.Sanjeev K. Bandlish apprised the house about the latest developments with regard to wage revision. Com.Bandlish informed that IBA has called for further discussions in regard to wage revision on 12.10.2018 at Mumbai.

Thereafter, Com.Bandlish advised the National Executive Committee of NCBE that this meeting has been called mainly because of Government's move to merge three Public Sector Banks viz.Bank of Baroda, Vijaya Bank and Dena Bank and to discuss about the resultant effect in these Banks. Members from almost all affiliates deliberated on the issue widely and in turn they assured the chair that strenuous and continuous efforts will be made to make all efforts to keep the flag of NCBE high. The House in one voice passed a resolution opposing this move of Government to merge three Public Sector Banks and authorised the President and the General Secretary to take any decision on behalf of NCBE.

Later, in the interim vacancies that have arisen since the last Meeting, the under-noted co-options to the National Executive and Central Committee positions mentioned thereagainst their names were proposed by the General Secretary and were unanimously approved by the House:
