**GENERAL SECRETARY** 

The meeting of the Executive Committee of NCBE, Odisha State Federation was held at Cuttack (SBISA Co-op. Society Building "Abhinaba", CDA, Sector-6) on 15<sup>th</sup> October 2017. The meeting was presided over by the President Com. J. B. Mohapatra. Representatives of All Odisha Bank of Baroda Karmachari Sangha, United Bank of India Sramik Karmachari Samiti, All Odisha Indian Overseas Bank Employees Union and State Bank of India Staff Association were present. The members present were received by Com. Tapan Kumar Pal and Com. Suvendu Tarai on behalf of SBISA with flower bouquet and uttariya. Com. J.B. Mohapatra presiding over the meeting welcomed all the participants and specially welcomed the representatives from Indian overseas Bank who have rejoined the NCBE in the last General Body Meeting of NCBE held at Hyderabad. He then highlighted the role of NCBE as a major constituent of UFBU in securing the interest of Bankmen in the present economic scenario of the country.
