## **PAYMENT OF ARREARS ON IMPLEMENTATION OF 11<sup>TH</sup> BIPARTITE SETTLEMENT (BPS) ADHOC COLLECTION OF LEVY**

In response to our earlier Circular No.14 dated 18<sup>th</sup> November 2020, the authorisations from almost all of our bonafide members have been collected for deduction of Levy @ 2.5% of Gross Arrear. It is a pleasure to inform you that the arrears have been credited on 16.01.2021 and individual calculation sheet is reflected in HRMS site. But the Circle consolidated data of arrear payment is not available in HRMS due to some technical reason. So, the undernoted **ad-hoc amount of levy** has been deducted from the salary of January 2021 under the captioned of “**Union/Association membership**”.
