“The Central Executive Committee of State Bank of India Staff Association (8 Circles) in its meeting decided to hold its Triennial General Council meeting coinciding with the Triennial Circle General Council Meeting of Delhi Circle. The Triennial General Council Meeting of State Bank of India Staff Association (8Circles) was lastly held at Puri in September 2018 and was due to be held this year.

It has been decided by State Bank of India Staff Association, Delhi Circle to hold its Triennial Circle General Council Meeting on 28<sup>th</sup> November 2021 **at Hotel Gardenia, Plot No.1, SIDCUL, Haridwar (Uttarakhand) and as per the decision of the Central Executive Committee**, thus the Triennial General Council Meeting of State Bank of India Staff Association (8 Circles) will also be held on 28<sup>th</sup> November 2021 at Haridwar coinciding with the Conference of Delhi Circle.
