We reproduce hereunder the full text of Circular No.13 dated 02.09.2021 issued by Com. Sanjeev Kumar Bandlish, General Secretary, All India SBI Staff Federation, the contents of which are self-explicit for information of our units/members.

"The Council Meeting of All India State Bank of India Staff Federation was held on the 28th August 2021 at Mahabalipuram(TN) to discuss the agenda items as per the Notice. The council meeting was chaired by Com.G.Kripakaran in the absence of Com.Arun Bhagoliwal, President.

In the beginning of the meeting **one minute's silence** was observed for all the members/office bearers (present and past) and the family members of our members who lost their lives during the COVID-19 pandemic and the sudden demise of Com.N.Komal Das, former President of SBSU(Kerala Circle) who passed away on the day of meeting i.e.28.08.2021

2. The minutues of the last Council Meeting held at Hyderabad on 22.08.2019 were unanimously approved by the House.

3. Thereafter, the house unanimously approved the cooption of Com.Arun Bhagoliwal as President-AISBISF, which took place in the Federation Executive Committee Meeting of AISBISF held at Lucknow on 27.03.2021, amidst thunderous applause.

4. The General Secretary advised the house that the Central Bipartite Meeting with the State Bank of India Management was held on 27.08.2021 at Mahabalipuram and explained the issues which were taken up in the meeting on behalf of the Federation alongwith the response(s) of the management.

5. The General Secretary advised the house about the latest developments that have taken place after 22nd August 2019 i.e.Council Meeting of the Federation held at Hyderabad at the Bank level viz.successful signing of XIth Bipartite Settlement with IBA and Bank level agreement, Compassionate Appointment, Payment of Performance Linked Incentive, Agreements with the Bank on Career Progression-Reduction in Service to 8,16 Years For Technical And Maintenance Staff, Utilisation Of SSL Employees as Floor Coordinators in Urban/Metro Branches, Promotion of Technical Staff(Liftmen) in Subordinate to Clerical Cadre, Promotion from Cook-Bearer-Subordinate Cadre to Steward in Clerical Cadre at Mumbai, Promotion from Clerical to T.O.(Systems)-New Channel, Issues-Joining Time on Transfer-Award Staff, CPS-Reduction in Service to 8,16 Years from 15/23 years for Subordinate Staff Category, etc.

6. The General Secretary advised the house about the number of non-members consequent upon merger of erstwhile Associate Banks with State Bank of India and advised all the Affiliates to follow up the membership position at the Circle level and try to bring in maximum employees to our fold who are non-members or otherwise.

7. The General Secretary advised the house that we used to have a joint forum with Officers' Federation and under that banner only we had observed the indefinite strike during 2006 for 8 days and have fought for many issues from the Joint Forum and achieved the same. From the last more than a decade, the forum was virtually non existent and now from 2020 onwards we have revived the same forum and have addressed many a issues jointly with the management such as creation of FIMM, one day salary proceeds contribution to the Prime Minister's Relief Fund, Payment of PLI, appointment of Apprentice, Work from Anywhere for CCPC staff etc.

8. The house unanimously approved the accounts of the Federation with thunderous applause for the Calendar year 2019, 2020 and for the Financial year 2019-20 & 2020-21 alongwith Income and Expenditure for the period 01.04.2021 to 31.07.2021.

9. The General Secretary further apprised the house about the pending payment of Affiliation Fee for the year 2021 and pending Levy on account of XIth Bipartite Settlement to all the Affiliates.

10. The General Secretary put forth the agenda about the stand to be taken for ther Principal Positions in NCBE i.e.Working or Retired. The issue was discussed at length by all Affiliates and it was decided to take forward the view of the Federation to the Central Committee Meeting of NCBE as the opinion of one of the Affiliate for consideration of the house.

11. The house unanimously co-opted the undernoted members in the Executive/Council of Federation to the interim vacancies arisen on account of retirements, creation of new modules etc. on the recommendations of Affiliate Circle Unions:
