CENTRAL COMMITTEE MEETING HELD ON 29.08.2021 : MAHABALIPURAM

We reproduce hereunder the full text of Circular No.12 dated 06.09.2021 issued by Com. Sanjeev Kumar Bandlish, General Secretary, National Confederation of Bank Employees, the contents of which are selfexplicit for information of our units/members.

"The Central Committee of National Confederation of Bank Employees was held on the 29th August 2021 at Hotel Four Points, Sheratan, Mahabalipuram(TN) under the President ship of S.C.Balaji, wherein the undernoted decisions were taken.

- At first, Com.Sanjeev Kumar Bandlish, General Secretary read out the minutes of the last Central Committee Meeting held on 22.8.2019 at Hyderabad and the house approved the same with big applause.
- Thereafter, The General Secretary apprised the house about the latest developments at the Industry level and successful signing of XIth Bipartite Settlement with IBA. Com.Bandlish further elaborated the highlights of the XIth Bipartite Settlement for which the house gave a big applause.
- Com.Bandlish advised the house that the meeting of UFBU constituents was held on 25.08.2021 at Mumbai wherein has been decided to continue our struggle against privatisation of Public Sector Banks and agitational programme in this regard will be sent to all the constituents shortly.
- After this, all the Federating Unions were apprised about the pending Annual Affiliation Fees and Levy payable by them towards NCBE, which was well responded by the Affiliated Federating Unions and assured to remit the pending affiliation fees and Levy amount at the earliest.
- Thereafter, the Committee unanimously approved the accounts of NCBE for the calendar year 2019, 2020 and Financial Yead 2019-20 & 2020-21 and financial statement for the period 01.04.2021 to 31.07.2021.
- Com.Bandlish advised the house that the last Triennial General Body Meeting of NCBE was held on 02.10.2015 at Nashik and is due to be held and further advsied that date amd venue to hold Triennial General Body Meeting of NCBE will be advised later on.
- Bandlish asked all the members of Central Committee to form the State Units wherever these have not been formed and asked the State Units to conduct the meetings as and when it is due to strengthen the State Units and asked them to give full support to the minority unions working in their State.

9. Agenda about Principal Positions in NCBE i.e.Working or Retired was discussed at length wherein all the Federating Unions put forth their view points and it was decided to constitute a committee to arrive at decision in this regard.
